

Ancillary Activity Exemption – Notification Guide

January 2021


This guide is designed to assist with the submission of the annual notification confirming use of the ancillary activity exemption under article 2(1)(j) of MiFID as onshored under the UK MiFID framework.

You will need to undertake an assessment of your activities as set out in UK RTS 20 and determine whether you satisfy the criteria for use of the exemption. This will need to be done on an annual basis and a notification submitted if you are exempt.

This form is for the use of persons professionally arranging or executing transactions, market operators and investment firms that operate a trading venue to make a report to the FCA under Article 16(1) and 16(2) of Regulation (EU) No 596/2014 of the European Parliament and of the Council on market abuse ("The Market Abuse Regulation").

PSD2 Exclusion Notification
This form is for creating PSD2 Exclusion Notification.

Commodity Position Limit Exemption Form
This form is for the use of a non-financial entity holding a qualifying position in a commodity derivative, who wishes to apply for an exemption from position limits, as referred to under Article 57 MiFID II and Commission Delegated Regulation (EU) 2017/591.

MiFID II Ancillary Activity Exemption: Notification Form
This form is for use by persons who are exempt from the requirement for authorisation under MiFID II, to notify the FCA annually that they make use of this exemption, as required by Article 2(1)(j) MiFID II.

Electronic Trading Notification Form
This form is the means by which an investment firm that provides direct electronic access (DEA) and/or undertakes algorithmic trading (as defined in Article 4 of MiFID II and further specified by the MiFID II Delegated Regulation) should notify the FCA in accordance with MiFID II.

Ancillary Notification

To qualify for this exemption the notifier must meet the criteria set out in Article 2(1)(j) of MiFID II Persons:

- i. dealing on own account, including market makers, in commodity derivatives or emission allowances or derivatives thereof, excluding persons who deal on own account when executing client orders, or
- ii. providing investment services, other than dealing on own account, in commodity derivatives or emission allowances or derivatives thereof to the customers or suppliers of their main business; provided that:

- for each of those cases individually and on an aggregate basis this is an ancillary activity to their main business, when considered on a group basis, and that main business is not the provision of investment services within the meaning of MiFID II or banking activities under MiFID II, or acting as a market-maker in relation to commodity derivatives;
- those persons do not apply a high-frequency algorithmic trading technique; and
- those persons notify annually the relevant competent authority that they make use of this exemption and upon request report to the competent authority the basis on which they consider that their activity under points (i) and (ii) is ancillary to their main business.

Further guidance on this exemption and qualifying threshold tests can be found in the regulatory technical standards prescribed under Article 2(4) of MiFID II, accessible via this link <http://eur-lex.europa.eu/legal-content/EN/TXT/PDF/?uri=CELEX:32017R0592&f=to-RTS-20> and relevant rules and definitions.

By submitting this notification you are confirming that you have understood and meet all qualifying criteria for the ancillary activity exemption as set out in Article 2(1)(j) of MiFID II. The FCA may at a future date contact you and require evidence to support this exemption.

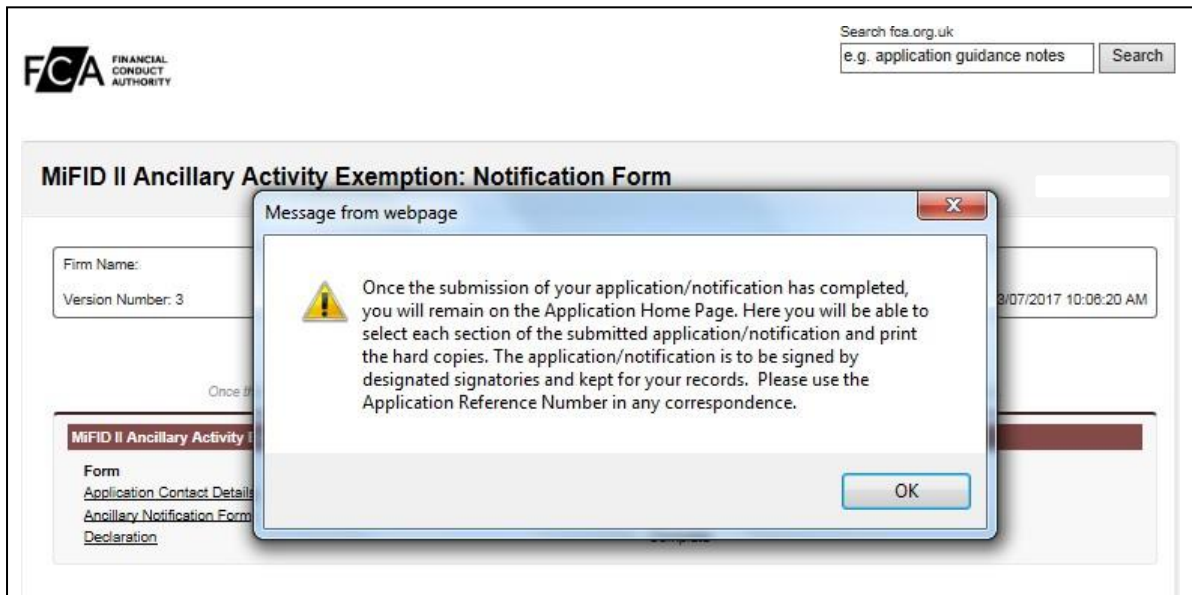
